The Students can write essay on any theme related to legal or socio legal issues.

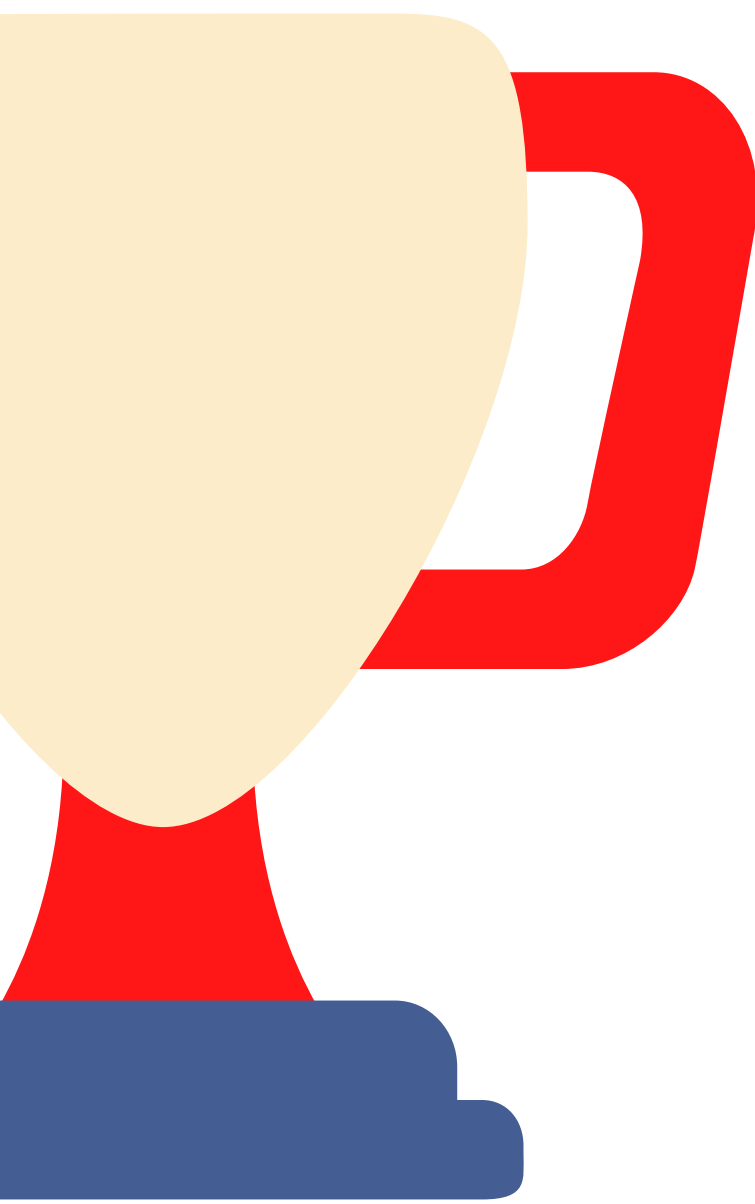
THE COMPETITION ELIGIBILITY

- The footnoting should be done in Times New Roman, font size 10 and line spacing 1.0.
- The essay must be original and unpublished as any form of plagiarism will result in disqualification of the essay.
- The essay must be in MS Word document format.
- In addition to sending the essay as an attachment, you must include your name, mailing address, and the university or school that you're enrolled in.
- All submissions of essays shall be made in soft copies to info@excelegal.in and the subject of the mail should be **"Third essay writing competition"**.

- All articles must be in doc. Or Docx format. The page layout must be A4.
