It is a global initiative taken to encourage discourse on the changing dynamics of legal education in the contemporary setting.

The current COVID-19 era has forced the educationists to think beyond the conventional classroom-based pedagogy supplemented with moot court activities and internship and led us to the development and amendments in the methods of legal learning and teaching. Law Universities have tried to overcome the digital divide and adopt the best technology to cater to the needs of students.

The apocalyptic nature of COVID-19 continues to influence ideological and institutional perspectives worldwide. This is evident in the rise of virtual learning platforms. Despite the technological convenience, these alternative modes of learning have thrown new challenges to academicians and students.

The Ministry of Education has acknowledged the significance of the aforesaid change in legal pedagogy and challenges incidental in the National Education Policy (NEP) 2020. NEP 2020 is an ambitious attempt to revisit the existing policies and tailor them to positively affect the Indian legal system.

It replaces NEP 1986 because it failed to address contemporary challenges to the education sector in India.

NEP 2020 focuses on flexibility while delivering quality education. The new strategy reflects in the values of multidisciplinary learning and critical thinking. Two of the most important introductions to this policy are the Right to Education until the age of 18 and the establishment of a national assessment center called PARAKH (Performance Assessment, Review, and Analysis of Knowledge for Holistic Development) as a standard-setting body within the Ministry of Education to ensure a quality check on our education system.

Effective implementation of digital infrastructure and online teaching tools have increased the accessibility of law universities to a wider audience. It has encouraged law schools to accommodate flexibility in the deliverance of academic knowledge and practical training through a multidisciplinary, tech-savvy approach.

During the 3rd edition of the National Amity Faculty Development Programme, the above aspects of legal education will be dealt with in detail. This shall be achieved through sessions focused on the interdisciplinary exchange of knowledge between law and other disciplines.

The sessions will serve as platforms to explore solutions, ideas and mechanisms essential to deal with emerging issues pertinent to the theme. They will be designed to appeal to a greater audience comprising faculty, law professionals and research scholars from across the country.

The online Faculty Development Programme will serve as an opportunity for the participants to engage in an intellectually stimulating environment and learn from the most venerated academicians and professionals in the country. It aims to offer a channel of open-minded, comprehensive and analytical discourse on the current framework of legal education, policies and the problems affecting the system.

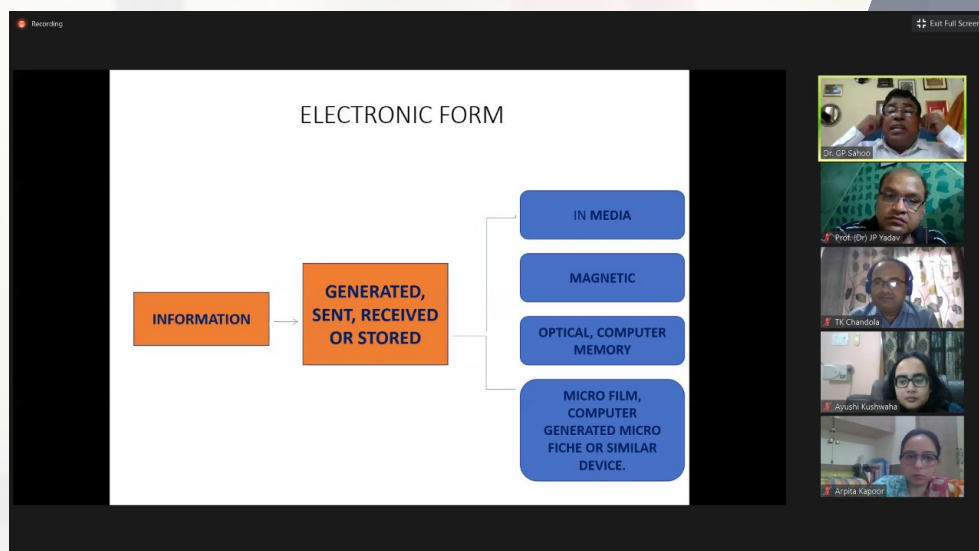




# ABOUT OUR PREVIOUS FACULTY DEVELOPMENT PROGRAMMES

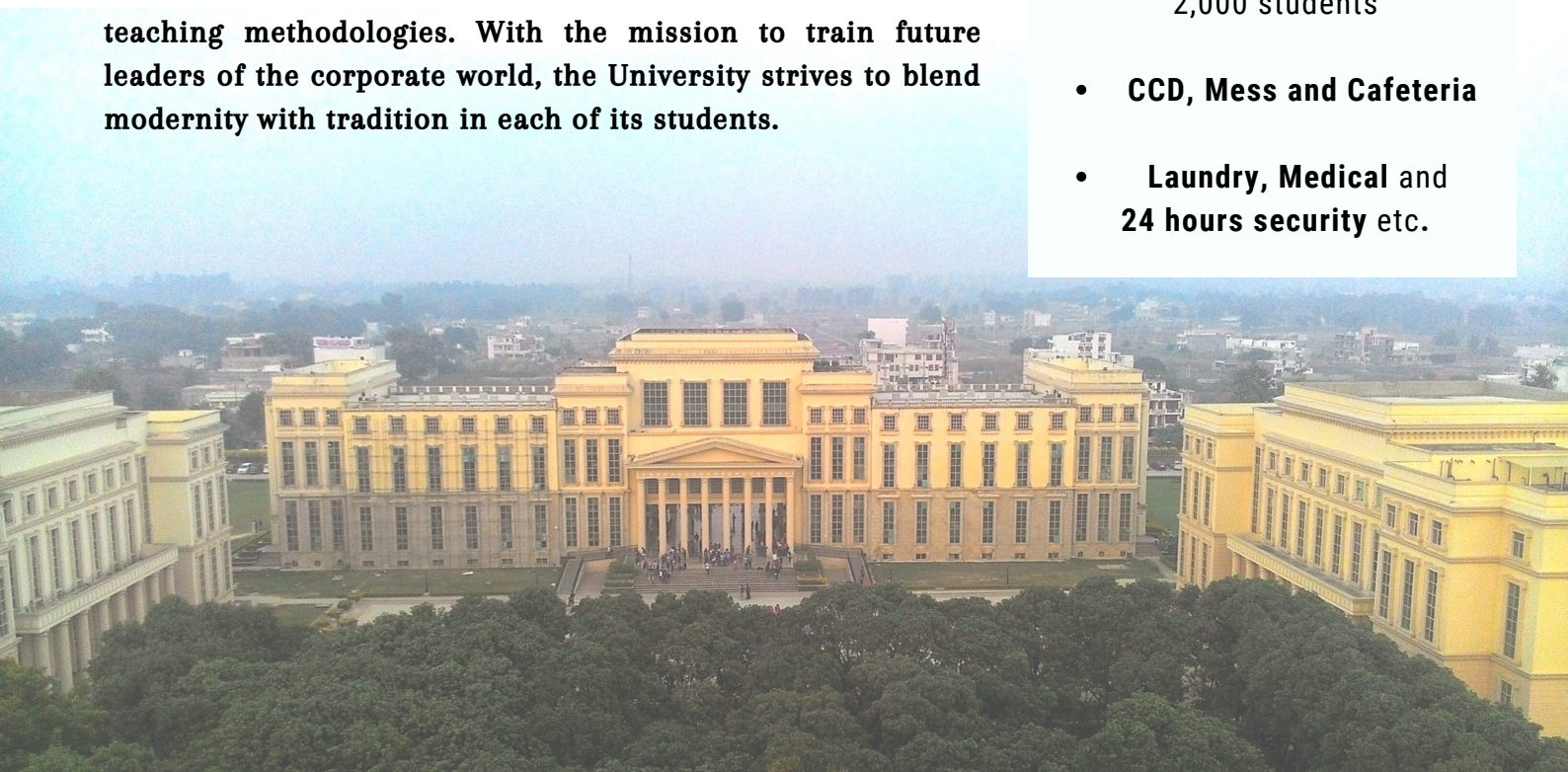
