# ABOUT THE NATIONAL MEMORIAL DRAFTING COMPETITION 2022

Learning outcome from moot, hones all the skills necessary to become an excellent lawyer in today's competitive world. However, in a moot court competition, the oral arguments take away much of the acclaim clouding the efforts taken by researchers and drafters for a well researched and drafted memorial. Hence, we present National Memorial Drafting Competition 2022 to provide an environment where aspiring lawyers can enhance their legal proficiencies. We hope that with this competition the researchers and drafters get the much needed recognition they deserve.

## THEME

According to National Commission for Women (NCW), nearly 31,000 complaints of crimes against women were received in 2021. There was a 30 per cent rise in complaints of crimes against women in 2021 as compared to 2020 when 23,722 complaints were received. From July to September 2021, over 3,100 complaints were received every month; the last when over 3,000 complaints were received was in

November, 2018 when India's #Me Too movement was at its peak. As many as 1,819 complaints have been received regarding the offence of outraging modesty of women, 1,675 complaints of rape and attempt to rape, 1,537 of police apathy against women and 858 complaints of cyber crimes, according to NCW data. (As reported in The Indian Express)

The government needs to gear up with strict checks, to ensure that the laws effected for protection of women and children are in compliance with the dynamic and fast growing society where crimes too increase every second at every nook and corner specially those targeted against women and children from the less privileged class. It is also the duty of the legal system as well as the society as a whole to ensure that crimes against women and children are curbed to reduce and to go zero with the progression of crime. Hence, the Department of Law, PIMR (Indore) in association with SAMARTH - Women Studies Centre of Department of Law and Team ProBono India are coming up with this National Memorial Drafting Competition 2022 based on protection of right to life and personal dignity of a woman in India.

# GENERAL RULES & REGULATIONS

## 1. Eligibility:

- The students currently enrolled in either FIVE YEARS B.A. LL. B(Hons.)/ B.COM LL. B (Hons.)/ BB. A. LL. B (Hons.) or THREE YEARS LL.B. courses or LL.M. programs from any recognised University/ Department/ College/ Institute/ Law School are eligible for participation in the competition.
- There is no restriction on the number of eligible teams from a single University/Department/College/Institute/Law School.

## 2. Team composition:

- Individual participation as well as participation in a team of two is allowed. However, more than two (2) participants in a single team are not allowed.
- The competition does not allow 'cross - institutional' teams.
- No changes will be made to the team composition after registration without express permission of the organising body.

## 3. Official Language:

- The official language of the competition is English.

## 4. Point of Contact:

- The organising committee (OC) shall function as the point of contact and any changes in the rules of the competition shall be notified by email to all participating teams.

## 5. Disqualification:

- The competition shall be conducted in accordance with the rules mentioned hereunder. Participants are required to comply with the rules and procedures prescribed therein. Non - compliance to the rules and procedures will result into disqualification.
- Participants must not reveal either institute's identity or their names during the entire competition. Each participant will be identified by the unique code. Once it has been allotted, all communications with the administrators or Judges thereafter will be done through the Code only. Violation of anonymity or scouting at any point shall lead to immediate disqualifications.
- The written submission shall not bear the logo, name, etc. of the participant or University/ Department/ College/ Institute/ Law School.

## 6. Dress Code:

- The dress code for the participants during Inaugural ceremony, orientation programme and valedictory ceremony shall be Black and White formals for males and females.

## 7. Rights reserved:

- The organising committee reserves the right to amend, change, modify or repeal any rules at any point of time. The OC shall communicate any changes made in the competition rules to the participants via - sayali\_bandi@pimrindore.ac.in or sumit\_maheshwari@pimrindore.ac.in

# GUIDELINES FOR MEMORIAL DRAFTING

1. All memorials submitted for the purposes of the Competition shall strictly adhere to the rules as stated below.
2. The participants have to prepare a Memorial/Written Submission for both the sides, i.e. Petitioners and Respondents.
3. There shall be no speaking footnotes and endnotes in the memorial.
4. The cover page of the memorials sent, for the soft copies, shall clearly mention the word "P" for memorials on behalf of the Petitioner, and the word "R" for memorials on behalf of the Respondent, followed by the team code, such being clearly inscribed on the top right corner of the cover page of both the memorials. (For example, if a team had been assigned code '21', the memorials sent by such team shall have "P21" and "R21" clearly marked on the top right corner of the cover page of the respective memorials.)
5. The participants have to follow the MANU citation method as stated in the rules, for citation throughout the memorial, with strict adherence.
6. The Memorials must include all the following specifications -
  - Cover Page
  - Table of Contents
  - List of Abbreviations
  - Index of Authorities
  - Statement of Jurisdiction
  - Statement of Facts
  - Issues Raised
  - Summary of Arguments
  - Arguments Advanced
  - Prayer
7. The Cover Page of the Memorial must follow the following colour scheme - Blue for the Petitioner Cover Page and Red for the Respondent Cover Page.

8. The Cover Page must contain
  - Team Code on the top right corner of cover page
  - Name and year of the Competition
  - Name of the case
  - The side for which the Written Submission has been prepared
  - Name and place of the forum resolving the dispute
9. The Memorial may consist of an annexure if needed. But must not contain any Photographs/Sketches/Exhibits/Affidavits etc.
10. The participants are required to mention only those abbreviations which are used in the memorial. If an abbreviation is found in the 'List of Abbreviations' but not used in Memorial, it will attract penalty. The 'Index of Authorities' must reflect the pages of Memorial where any authority is cited.
11. To conserve paper, participants may print their memorials on both the sides of the A4 sheets.

# GUIDELINES FOR MEMORIAL SUBMISSION

## A. HARD COPY SUBMISSION

1. The hard copy of Written Submission shall be spiral bound only.
2. The registered participants shall send one (1) printed copy (for each side) of such memorials by 20th April, 2022; 5.00 pm, addressed to:

3. Delay caused by courier services shall not be considered by the Organising Committee. Participants are required to send the hard copies of the written submissions well in time, taking all the contingencies into account.
4. The hard copies of the Written Submissions must be identical to the soft copies of the Written Submissions sent by the participant. Any violation of this rule shall attract penalty. The decision of the Organising Committee in this regard shall be final and not subject to challenge.

## B. SOFT COPY SUBMISSION

1. The participants shall submit the memorial in the PDF format (.pdf) and Microsoft Word Document (.docx/.doc) for both the sides via mail by 13th April, 2022; 10.00 pm at pimrmemorialsubmission@gmail.com.
2. The Memorial for each side should be submitted as one single file and not in multiple files.
3. While submitting the memorials, participants are supposed to name Respondent's memorial as 'R' accompanied by the unique code and Petitioner's memorial as 'P' accompanied by the unique code. For example, for a participant assigned a code of UC 10, the PDF file for the Respondent should be named as 'R10' and that for the petitioner should be named as 'P10'.



4. Any soft copy submission after 10.00 pm of 13th April, 2022 shall not be accepted and the participant will not be allowed to participate in the Competition, except at the Discretion of the Organising Committee. The decision of the Organising Committee shall be final in this regard.
5. It is the responsibility of each Team to ensure that the electronic copies of the Written Submissions:
  - (a) can be opened and read with Adobe Acrobat Reader Version 8 and Microsoft Word 97- 2003 Document (through use of compatibility mode) or a later version and do not contain any virus;
  - (b) are submitted as four (4) separate file attachments: two (2) as Written Submission for the Petitioner(s) [one each in PDF and Microsoft Word (.docx/.doc) format] and two (2) as Written Submission for the Respondent(s) (one each in PDF and Microsoft Word (.docx/.doc) format); and
  - (c) are named according to the Unique Code and the side for which the Written Submission is prepared. The Unique Code must be written on the upper-right hand corner of the cover page in the format prescribed.
6. Any decision of the OC regarding the deductions shall be final and not open to challenge.

**Note: -**

1. *If the memorial of two teams will be similar to each other then both the teams will be disqualified.*
2. *After the completion of the competition, the Organising Committee reserve the right to use the memorials as they deem appropriate.*

# MOOT PROPOSITION

Hindimai, one amongst the developing countries, has a population of more than 1300 million. According to the world crime index it stands at eighty fourth position and most crimes are against women and children. Reportedly there have been over 70 rape cases a day in Hindimai ever since the pandemic outbreak. It has been also seen that there has been a dip in rape by strangers and an increase in rape by known ones. Owing to the abusive environment amongst certain classes of homes more than 20% of the total female population has been relocated to government aided NGOs or Shelter Homes. There are other un-aided shelter homes which are run by religious missions. One such shelter home is that run by a religious group called Canayanos. Canayanos was headed by the religious head Meshaline aged 60.

Meshaline had started of his celibacy life at the age of 18. And gradually grew to become the religious head by the age of 35. He was the one behind the idea of setting up 'Kristhish Home', shelter home for women and children, pan Hindimai. He got the approvals from the necessary religious authorities and the government authorities as well. They used to do missionary works and approached homes which were below poverty line and used to promise to support their children to grow successfully in life, provided they were kept at the shelter homes. Many parents willingly sent their children to these homes in order to see their children have a brighter future. They also went ahead and forced families for religious conversion which created an uproar in many parts of Hindimai by the other religious groups.

One such inmate is Sefina, native of Koshin, state in Hindimai. She had been at Kristhish Home ever since she was 16 years of age and now being in her mid-forties mustered the courage to join the "ME TOO" campaign that had been triggered off by famous actress Yamini. Sefina had accepted a celibate life ever since she had joined Kristhish Home. However, she voiced how she was sexually abused till date, by Meshaline. She also alleged that many children who were reported as missing from the shelter home were in actual not missing but they were being sold to many wealthy business men who used to fund the shelter homes in public. She also alleged that many children were initially sexually manipulated by Meshaline & many succumbed to the injuries in the process. The parents of these children were made to believe that they had fallen sick & died. The bodies of the children were cremated as soon as it was received by parents. She also claimed that people who cooperated with Meshaline were influential people who created forged documents to escape law.

This incident was investigated but did not yield any result and Sefina claimed that the police officials were biased and they were protecting Meshaline. The claims of Sefina witnessed massive public support. Simultaneously, Sefina also went into hunger strike in front of the Legislative Assembly to gain attention of the Chief Minister and other Ministers. There were couple of other inmates too who were in agreement with Sefina's statement. The people from her town Alaapy in Koshin urged the government to appoint CBI to investigate into the case. The CBI investigated the case and they came up with their findings that there is no co-relation to explain the children's death and sexual abuse of these children. However the shelter home authorities stated that Sefina and the other two inmates along with her decided to go against Meshaline and other religious members since she was not promoted and given the title Canayan Lady Superior. According to them, she was not worthy of that title since she had disciplinary proceedings pending against her. However, Sefina denied this allegation and said the disciplinary proceedings were framed to dissuade her from pursuing her complaint against Meshaline and others.

Khwaja, an investigative journalist, through reliable sources had collected evidence on the basis of Sefina's claims and he, along with Sefina's father Mr. Ramoven, approached an NGO called Women of Hindimai (WoM) to file complaint against Meshaline. Mr. Ramoven also mentioned that they were being threatened by Meshaline's goons so that Sefina would drop the case and protest against Meshaline. The media took up the case and soon there were many other inmates, of Kristhish Home pan Hindimai, who came ahead to support Sefina. Similarly, inmates from several other homes, both aided and unaided came out in support of Sefina claiming that they were also victims of abuse, both mental and physical.

Women of Hindimai approached the High Court of Koshin with a Public Interest Litigation demanding justice for Sefina where it was first filed. Similarly, inmates in other states also got their cases registered in their respective High Courts. All the cases in the High Court are pending.

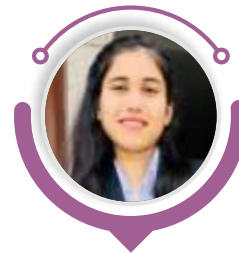
