

About the workshop

Program Objectives

1. Certification and Accreditation

2. Trainers

3. Role plays and simulations with Case studies

4. Restorative practices

It is Accords International's unique model of mediation learning program where we introduce the implementation of restorative practices in mediation.

5. 60-hours learning program, Duration (Excluding breaks)

It is a 60-hours learning program divided as below:

- 1. Theory and PPT- 19 hours
- 2. Demonstrations, Role Plays, and simulations (17 hours)
 - Opening Statements- (5 hours)
 - Role play demonstration- 1 hour
 - Complete Role Plays- 11 hours
- 3. Negotiation activity-1 hour
- 4. Homework -[1.5 * 5] = 7.5 hours
- 5. Reading-5 hours
- 6. Quiz and other activities 3 hours
- 7. Assignment Submissions (4.5 hours)
 - 1 session report (the students will be asked to actively listen to the sessions and they have to submit one report on the choice of their session.)
 - Mediation Agreement- (Every student is required to submit a mediation agreement within 7 days of completion of the program)
 - Settlement Agreement (Students will be taught how to prepare a settlement agreement. Every student is required to submit one settlement agreement on the basis of a case study in which he/she played the role of a mediator within 7 days of completion of the training program).
- 8. Assessment- (3 hour)

6. Supervision, Coaching, and Individual Attention

All the participants get individual attention from our lead trainers and experts.





7. Feedback

Our trainers and experts have curated a program that works on the basis of two types of feedback:

- Participants will get detailed feedback from trainers regularly. And will be given a chance to work on their shortcomings.

All the participants will be peer-reviewed. Everyone will be given an assessment sheet and will get trained in how to do peer reviews.
