- Co-Authorship is allowed with up to 2 authors per Chapter.
- All submissions are to be made in Bookman Old Style font, Size 12, Line Spacing 1.5, 1-inch margins on all sides on an A4 Paper. Footnotes shall be Size 10.
- ILI Citation Format has to be followed for Uniform Footnoting.
- Any Chapter which has been published previously or which is under consideration for publication shall be disqualified.
- All papers will be Peer-Reviewed by the Editorial Board, and the authors shall be given a 5-6 day time period for editing their book chapters as per the needs of the Editors/Plagiarism Report.
- Decision of the Editors shall be final and binding.
- The upper limit of Plagiarism shall be 10% only.
