

- THE FOOTNOTES SHALL BE IN TIMES NEW ROMAN, SIZE 10, SINGLE LINE SPACING, JUSTIFIED. AUTHORITIES SHALL BE CITED AS PER THE 20TH EDITION OF THE BLUEBOOK.
