The conference will be organised in a hybrid mode on March 28-29, 2023 in order to provide opportunity for discussion of opinion of all relevant stakeholders in relation to theme of the conference.

## CALL FOR PAPERS

---

This Conference invites research papers including but not limited to the following themes on the inter-disciplinary subject of Law and various aspects of Social Justice and Inclusiveness:

1. Protection of Rights through Judicial Activism
2. Inclusion of Marginalised Sections in Policy making
3. Human rights of farmers vis-à-vis Food security
4. Protection of Rights of Person with Disabilities
5. Right to Education in 21st Century.
6. Protection of Child Rights vis-à-vis National & International Initiatives
7. Achieving Social Justice through Democratic Decentralisation
8. Protection of Human Rights of Migrant Workers in India
9. Sustainable Urbanisation vis-à-vis Social Development
10. Collective Rights and Constitution of India

The listed themes are merely indicative, the candidates are free to choose any other subject resonating with the concept of Social Justice and Collective Rights.

## RULES AND GUIDELINES

---

### 1. LANGUAGE

The language of the event shall be English.

### 2. DEFINITIONS

- “Conference” here means The National Conference on Social Justice and Collective Rights, 2023.
- “CHRGs” means the Centre for Human Rights, Gender & Social Inclusion.
- “Identity” means any fact of the identity of an individual/a team/its members, or the College/University/Organisation represented by the individual/team and the state or region where such College/University/Organisation is located and includes any identification marks/ seal of the individual/team or the College/University/Organisation represented.

- “Organizing Committee” or “OC” means the Organizing Committee Members from the CHRGS.
- “Paper” means an unpublished, original manuscript for the purpose of this Conference.
- “Participant” means a candidate submitting a paper but not presenting.
- “Presenter” means a candidate submitting and presenting a paper.
- “Team” means the structured unit of the registered participant(s)/presenter(s) of the Competition. Each team shall consist of one individual or two individuals that qualify the eligibility criteria.
- “University” here means Jagran Lakecity University.

### 3. INTERPRETATION

The Centre will have exclusive authority to interpret the Rules in the interest of fairness and equality. The interpretation placed upon these Rules by the Organizing Committee shall be conclusive and the decision of the Organizing Committee regarding the application of these Rules shall be final.

### 4. KEY DATES

The following key dates shall be adhered to:

- Last Date for Submission of the Abstract: 6<sup>th</sup> March, 2023
- Date for intimation on selection of Abstract: 7<sup>nd</sup> March, 2023
- Last Date for Registration and Payment of Registration fees: 13<sup>th</sup> March, 2023
- Last Date for Submission of Manuscript: 23<sup>rd</sup> March, 2023
- Date of Paper Presentation: 28<sup>th</sup> - 29<sup>th</sup> March, 2023

### 5. ELIGIBILITY

Authors must be:

- pursuing their 5-year/3-year LL.B. course/ LL.M from any recognized university in India or an equivalent law degree abroad for the academic year of 2022-2023, or,
- academician/professor, or,
- Legal researcher, or,
- Lawyer and/,
- other scholars in related disciplines of research and training, to be eligible to participate in the Conference.

## 6. REGISTRATION PROCEDURE

6.1. Author(s) must register themselves by filing the google form. (The link thereof has been attached in the “Important Links” section provided below.)

6.2. After acceptance of the Abstract, of which the candidate(s) shall be intimated through mail by 7<sup>th</sup> March, 2023, the team shall make the registration by paying the application fee on or before 13<sup>th</sup> March, 2023.

## 7. REGISTRATION FEE

For Presenters -

- Research Scholars & Students (Sole Authorship): INR 500
- Research Scholars & Students (Co-Authorship): INR 400 per author
- Academicians & Legal Professionals: INR 1000
- Academicians & Legal Professionals (Co-Authorship): INR 800 per author
- For JLU Students (Sole & Co- Authorship): INR 500

For Participants -

- Research Scholars & Students: INR 200
- Academicians & Legal Professionals: INR 500

- Candidates presenting at the university premises shall bear their own travel and accommodation expenses.

- The Candidates are required to submit the registration fee through a Google-Form. The link thereof has been attached in the ‘Important Links’ Section provided below.
- All participants are required to attach the screenshot of the payment of the registration fee as a proof of payment in the same Google-Form.

## 8. GENERAL RULES

- 8.1. Co-authorship is allowed up to a maximum of two authors.
- 8.2. Only one submission is allowed per author/team. Submissions, both as co-author and single author, will be treated as multiple submissions and will be disqualified as an entry to the Conference.
- 8.3. The manuscript should be original and unpublished work of the author(s) and any form of plagiarism is strictly prohibited.
- 8.4. The author(s) has to give a declaration of the originality of the work.
- 8.5. Author(s) shall solely be responsible for the accuracy of statements, opinion and views presented in the manuscripts.

## 9. GUIDELINES FOR THE ABSTRACTS

- 9.1. The abstract should not exceed 500 words.
- 9.2. Author(s) should mention the following specific details on front page while submitting Abstract :
  - a) Name of the Author(s)
  - b) Designation
  - c) Affiliation
  - d) Contact Number
  - e) Email ID
  - f) Title of the Submission
- 9.3 Font and Font Size : Times New Roman, 12, Line spacing 1.5 and Alignment ‘justify’
- 9.4 Submissions must be made in MS Word Format (.doc)/(docx) only.



## 10. GUIDELINES FOR THE FINAL MANUSCRIPT

- 10.1. Length of full paper : Between 3000 - 6000 words (excluding footnotes and title)
- 10.2. Font and Font Size : Times New Roman, 12, Line spacing 1.5 and Alignment 'justify'
- 10.3. Submissions must be made in MS Word Format (.doc)/(.docx) only.
- 10.4. Submissions made in any other format shall not be considered.

- 9.1. Footnotes : Font 'Times New Roman', Font Size 10, line spacing 1.
- 9.2. The citations must conform to the Bluebook Style of Citation, 20th edition.
- 9.3. It is not permitted to provide any information in the footnotes that is not related to the identification of an authority or source. Footnotes must not include additional legal arguments.
- 9.4. Endnotes are not permitted.

## 12. SUBMISSION GUIDELINES

All submissions must be made in English language only.

### 12.1. ABSTRACT:

- File name of abstract submission shall adhere to the style 'Abstract: First name of Author\_NCSJCR'
- The author(s) must submit the abstract by sending an email to the official email ID [chrgs.sol@jlu.edu.in](mailto:chrgs.sol@jlu.edu.in) on or before 6<sup>th</sup> March, 2023. The subject of the mail should be "Abstract: NCSJ"
- Acceptance of abstract shall be communicated by 7<sup>th</sup> March, 2023.

## FINAL MANUSCRIPT:

- The final manuscript is to be mailed on the official email ID on or before 23<sup>rd</sup> March, 2023.
- File name for the Final Manuscript submission shall adhere to the style “Title of the Paper\_NCSJCR”
- The subject of the mail should be “Final Submission: NCSJCR”
- No alteration would be entertained in the final submission once made.
- The paper then has to be presented in front of the panel on the day of the Conference, i.e., 28<sup>th</sup> - 29<sup>th</sup> March, 2023.
