

- Similarity Index Report from recognized Similarity Checker Software (Plagiarism Report below 10%).
- Contributions should be in English language only.
- Maximum one co-author allowed for book chapter.
- Email subject for paper presentation "Submission for Seminar Paper Presentation" and Email subject for book chapter "Submission for Book Chapter".

All submissions (in soft copy and plagiarism report) must reach the editor latest by 10th April, 2023 as per Submission guidelines.
