ABOUT THE THEME

Schedules are lists in the Constitution of India that categorize and tabulate bureaucratic activities and policies of the Government. Indian Constitution currently comprises 12 Schedules. One of the first mentions of Schedules was made in the Government of India Act, 1935 where it included 10 Schedules. The Indian Constitution originally had eight schedules. The 9th schedule was added via First Amendment Act, while 10th Schedule was first added by 35th Amendment [Sikkim as Associate State]. Once Sikkim became a state of India, the 10 Schedule was repealed but later added once again by 52th Amendment Act, 1985 in context with the "Anti-defection" law.

- Authorship is allowed with up to 2 authors per Chapter.
- All submissions are to be made in Times New Roman font, Size 12, Line Spacing 1.5, 1-inch margins on all sides on an A4 Paper. Footnotes shall be Size 10, should not put margin on borders.
- ILI Citation Format has to be followed for Uniform Footnoting.
- Any Chapter which has been published previously or which is under consideration for publication shall be disqualified.
- All papers will be Peer-Reviewed by the Editorial Board, and the authors shall be given a 5-6 day time period for editing their book chapters as per the needs of the Editors/Plagiarism Report.
- Decision of the Editors shall be final and binding.
- The upper limit of Plagiarism shall be 10% only.
- All submissions of abstract and chapter must be made only once at mentioned email id : lmpublications4@gmail.com
