- ILI Citation Format has to be followed for Uniform Footnoting.
- Any Chapter which has been published previously or which is under consideration for publication shall be disqualified.
- All papers will be Peer-Reviewed by the Editorial Board, and the authors shall be given a 5-6 day time period for editing their book chapters as per the needs of the Editors/Plagiarism Report.
