Sessions Judge, Ld. Additional Sessions Judge for Dhalai District and Assistant Public Prosecutor (APP) in the court of Judicial /Executive Magistrates for Longtharai Valley/Ambassa/Kamalpur/Gonda Twisa Sub-Division under Dhalai District.


Interested candidates may submit applications directly to the office of the DM & Collector, Dhalai District, Jawaharnagar within 05.07.2023 during office hours along with necessary relevant documents.

Name of Post	: Public Prosecutor, Additional Public Prosecutor and Assistant Public Prosecutor.
Total Post	: 13 (thirteen) Nos. (i) Public Prosecutor/ Additional Public Prosecutor- 2 Nos. (ii) Assistant Public Prosecutor- 11 Nos.
Qualification Required	: A candidate must have a degree in Law from any recognized University and be enrolled as a advocate with the Bar Council of Tripura .
Eligibility	: (i) For the post of Public Prosecutor/Additional Public Prosecutor: - Candidate must have experience of practice on criminal side as an advocate for not less than 7years. (ii) For the post of Assistant Public Prosecutor: - A candidate must have experience of practice on criminal side as an Advocate for not less than 3 years.

Terms and Condition:


1. The candidate must submit ink signed original application within 5.30 PM by 05.07.2023 as per format along with self attested copies of document addressed to the DM & Collector, Dhalai District, Jawaharnagar. No application will be accepted after the date and time as mention above.
2. Each candidate should also produce his/her original documents at the time of interview before the selection committee.
3. Incomplete and defective application in any form & containing incorrect information or suppression of facts will be summarily rejected by the appropriate authority without assigning any reason.
4. The date, venue and time of interview will be intimated to the individual applicant through their e-mail ID.
5. The character and antecedents of selected candidates may be verified and if found adverse his/her candidature will be liable to be cancelled.
6. The candidate should submit the copies of judgment of at least 3(three) cases, in which the applicant has appeared & conducted before the competent court.
7. The Chairman, Selection Committee reserves the right to cancel or reject any application without assigning any reason, if found defective.
8. No TA/DA will be paid to the candidates for appearing in the interview.
