SUBMISSION GUIDELINES

- The working language of the Conference and the presentations shall be done in English only.
- Co-authorship is permitted.
- The author(s) are required to send abstract of their paper, upon selection of which they will be required to send their paper.
- The Abstract must contain the highlights of the full paper and should not exceed 300 words. The softcopy of the abstract shall be submitted along with a cover page.
- Author(s) Name(s), University/Organization, Paper Title, Email Address and Mobile Number, to be stated clearly in the cover page of the Paper.
- No part of the paper should have been published earlier nor should it be under consideration for publication. Any form of plagiarism will result in immediate disqualification.
- Author (s) will be required to fill the registration form after the selection of their abstract. In case of co-authorship at least one author must attend to present the paper.
- An author may submit only one Article.

Abstract: Abstract should be up to 300 words including Key Words and contain the following details:-

- Sub-Theme
- Title of the Paper.
- Name of the Author (s)
- Designation
- University/Institution/Organization
- Contact Number
- Email Address

Full Paper:

- The Full Paper should be between 3000 to 5000 words (including Footnotes).
- The text English in Times New Roman with Font Size 12 and Line Spacing 1.5
- All references must be in the form of footnotes in Times New Roman with Font Size 10.
- Co-Authorship is permitted.
- Registration will be separate for each co-author.
- Entries must be Original and unpublished in any form.
- Any sort of Plagiarism will disqualify the entries.

Formatting Guidelines

- The text should be in Times New Roman, font size 12, spacing 1.5.
- The footnotes should be in Times New Roman, font size 10 with single spacing.
- APA Format to be followed for citation.
- One inch margins on all sides should be maintained.

Submission Process

All submissions must be made in soft copy to the aforementioned mail id- internationallawseminar@ipemgzb.ac.in with the subject of mail as “Abstract/Paper Submission for International Conference on Implementation of Human Rights, International Perspective: Issues and Solutions”, on or before the last date of submission.

All submissions must be made in word document format. The body of the email must contain details of the Author and the Title of the Paper.

Publication Opportunity

Papers guaranteeing merit after Plagiarism check shall be published in the form of Commemorative Volume as Book with ISSN number and/or in our reputed journal with ISSN number. The Organizing Committee reserves the discretion of the selection of the paper.
